

Call for Papers

**NIBM Conference on
Indian Banking System:
Way Forward on the Current Crisis**

March 9-10, 2019

The conference aims to discuss the current crisis in the Indian Banking Sector and envision how the various stakeholders can work towards finding ways out of the current crisis and creation of a robust Indian Banking Sector in times to come. Papers are invited along key track themes outlined below.

A. Tracks

Track I: Regulatory Environment

The papers in this track will address issues in areas like:

- Role of macro-prudential policies
- Regulatory Guidelines and their effectiveness
- Integration to global risk management standards
- International regulation and the Indian banking sector

Track II: Corporate Governance Aspects and Strategies

The papers in this track will explore issues such as:

- Government stake holding in banks
- Appointment of the heads of banks
- Managerial Incentives
- Bank Consolidation

Track III: Operational Efficiency

The papers in this track will cover topics broadly related to:

- Efficiency of financial sector
- Access and depth of the financial sector
- Profitability and New Income Streams
- NPA management

Track IV: Functional Aspects

The papers in this track will cover topics broadly related to:

- Human Resource Management
- Marketing of Financial Services
- Technology Driven Growth
- Development and Inclusive Banking

Please note topics outlined above in the respective tracks are indicative. Papers on any other aspect relevant to the theme of the conference are welcome.

B. Guidelines for Submission

- (a) All papers will go through a double-blind peer review process for selection.
- (b) All papers submitted for the conference must be original, not published or accepted for publication/presentation and not submitted concurrently to any other journal/ conference.
- (c) For enabling blind peer review process, please do not mention the name(s)/affiliation of the authors anywhere in the paper. A title page is to be prepared separately with the title of the paper, name of author(s), affiliation, address, e-mail for correspondence and contact number.
- (d) Suggested word limit for the paper is 6000 words, including tables and graphs (if any)
- (e) All references used should be properly cited. For all accepted papers, the author(s) will be required to format references using APA guidelines.
- (f) The paper is to be prepared in MS Word format (Font: Times New Roman, 12). The write-up must be double-spaced with 1 inch margin on each side.
- (g) The title should be clear and concise. Use font Times New Roman, 14, Bold for the title.
- (h) Abstract, not exceeding 150 words should be given.
- (i) Section headings should be numbered in Roman numerals (Font: Times New Roman, 12, Bold) and subsection headings should be numbered alphabetically (Font: Times New Roman, 12, Italics).
